



Current status on SUMPs in Slovenia

- 77 municipalities (of 212) with SUMPs
- Updated National SUMP Programme
- Active NTF as driver (PROSPERITY, Care4Climate)

Regulation

- Currently SUMP not legally binding or defined
- Municipalities encouraged to prepare them, funding available for development and implementation
- Challenges with quality assurance, regional cooperation, small / large municipalities, integration with spatial plans and other documents

Need for SUMP law now recognized, but approach not yet clear


