


A game changer for urban mobility, by strategically integrating high quality parking management into Sustainable Urban Mobility Planning (SUMPs)


Why parking management?

Why parking management?

- Relevant to small towns and tourist areas
- Improves quality of environment in key areas e.g. promenades, beaches, parks
- Visitor experience improved if parking easy to find, organised
- Prices, scale of management can vary by season




General project concept

- Raising **awareness** and gaining **acceptance** on how the ‘right parking policies’ can help cities
 - ✓ Moving from a reactive to strategic parking policy
 - ✓ Integrate parking management into SUMP
- Building **capacity**, esp. where parking management not much used
- **Implementing** new and more parking measures for cities
- Stimulating further **innovation** in parking management
- Delivering **behaviour change** whilst generating revenues




Some Park4SUMP outputs...




